The American Audiology Board of Intraoperative Monitoring (AABIOM) is recognized by the American Speech-Language-Association (ASHA) as a legally independent non-profit subspecialty entity in the profession of audiology. The AABIOM serves to ensure the provision of clinical intraoperative monitoring and interpretation services (IOM) to referring surgeons, health care facilities and their respective patients, by licensed and competent audiologists who demonstrate a broad fund of knowledge, advanced clinical training and particular clinical expertise in the subspecialty field of IOM. As such, the AABIOM directs and oversees a professional level subspecialty credentialing process, the end goal of which is specialty board recognition certifying an audiologist as having met specific educational, experiential and clinical competency standards.
